PLEDGE OF ALLEGIANCE

CALL MEETING TO ORDER: Mayor Bacon called the meeting to order at 6:08 p.m. Councilmembers present were Penny Kaufmann, Floyd Choyce, Janice Murrell, and Paula Bacon. Mayor Bacon declared a quorum present. Councilmembers absent were Paula Hagler Wampler, Stanley Holmes and Hector Torres. Also present were ACM/City Secretary Jo Ann Talbot and Municipal Judge Jon Burt.

1. Consider first reading and approval of Ordinance O-09-05 of the City of Kaufman, Texas, declaring the results of the Charter Amendment Election held in the City of Kaufman on the 7th day of May, 2005; declaring that such Charter Amendments Nos.1 and 2, are duly adopted and shall be a part of the Charter of the City of Kaufman; and declaring the results of Proposition No. 3 regarding the use of a portion of funds of the Economic Development Corporation sales and use tax proceeds currently being collected be used for the maintenance and operation of the Kaufman Sports Complex as authorized by the Texas Revised Civil Statutes Article 5190.6 Section 4B; directing the City Secretary to record the amendments in the records of the City; directing the City Secretary to certify a copy of this Ordinance to the Secretary of State; and providing an effective date.

Assistant City Manager/City Secretary Jo Ann Talbot informed the Council that 1250 ballots were printed for the May 7, 2005 City General and Special Election. The Election Judge, Linda Tackett, reported 402 votes were cast on Election Day. During the early voting period, 548 votes were cast with an additional 12 mail ballots totaling 560. There were two (2)

provisional ballots also counted, making a total of 964 valid votes. There was one (1) provisional ballot rejected, seven (7) spoiled ballots and two (2) mail ballots not returned. There were 276 unused ballots in Box #4, if the Council wished to count them.

The election returns for the Special Election for three propositions are in the body of Ordinance O-09-05 as follows:

Proposition No. 1. Amend current Article IX, "Municipal Planning & Zoning," of the City Charter by adding Section 9.04 to read as follows:

The Planning and Zoning Commission shall give written notice to be mailed to property owners within three hundred feet (300 feet) of property which is the subject of a proposed Zoning Change before the 10th day before the Public Hearing on the proposed change.

Proposition No. 2. Amend current Article IX, "Municipal Planning & Zoning," of the City Charter by adding Section 9.05 to read as follows:

The Planning and Zoning Commission shall give written notice to be mailed to property owners within three hundred feet (300 feet) of property which is the subject of a proposed change to the Thoroughfare Plan before the 10th day before the Public Hearing on the proposed change.

Proposition No. 3. The use of a portion of funds of the Economic Development Corporation sales and use tax proceeds currently being collected be used for the maintenance and operation of the Kaufman Sports Complex as authorized by the Texas Revised Civil Statutes Article 5190.6 Section 4B.

Councilmember Murrell moved and seconded by Councilmember Choyce to approve the first reading of Ordinance O-09-05 of the City of Kaufman. Texas, declaring the results of the Charter Amendment Election held in the City of Kaufman on the 7th day of May, 2005; declaring that such Charter Amendments Nos.1 and 2, are duly adopted and shall be a part of the Charter of the City of Kaufman; and declaring the results of Proposition No. 3 regarding the use of a portion of funds of the Economic Development Corporation sales and use tax proceeds currently being collected be used for the maintenance and operation of the Kaufman Sports Complex as authorized by the Texas Revised Civil Statutes Article 5190.6 Section 4B; directing the City Secretary to record the amendments in the records of the City; directing the City Secretary to certify a copy of this Ordinance to the Secretary of State; and providing an effective date. Mayor Bacon called for a vote with all members present voting AYE, the motion carried. Councilmembers absent were Paula Hagler Wampler. Stanley Holmes and Hector Torres.

2. Consider adoption of Resolution R-16-05 and order Canvassing Returns and declaring results of a General City Officers' Election held in for the Election of Kaufman, Texas on the 7th day of May, 2005, for one (1) Mayor and three (3) Councilmembers.

Mayor Bacon and Members of the Council reviewed the recount Tally Sheets for the May 7, 2005 City of Kaufman General Election. The Assistant City Manager/City Secretary Jo Ann Talbot read the Election Returns in Resolution R-16-05 declaring that Paula Bacon was duly elected as Mayor and that Lonnie Bounds, Gil Altom Jr. and Floyd Choyce were duly elected as Councilmembers.
